Lump sum bid proposals will be received for this project at the scheduled time of receipt of bids and will be publicly opened at that time. The bid opening will occur at the Quad Cities Campus, STB, Room No. 114, Black Hawk College, 6600 34th Avenue, Moline, Illinois 61265.

Bid security in the form of a bid bond, certified check, or cash in an amount equal to ten percent (10%) of the base bid amount shall be submitted with the bid. Should a bid bond be submitted, the bid bond shall be payable to the Board of Trustees. Black Hawk College.

Representatives from the College and the Architect's and Construction Manager's office will be present to answer questions regarding bidding procedures and project requirements. We encourage all bidders to visit the site to view site conditions.

The College reserves the right to reject any or all bids or parts thereof, or waive any irregularities or informalities, and to make the award in the best interest of the College. Decisions of the College will be final.

All bidders must comply with applicable Illinois Law requiring the payment of prevailing wages by all contractors working on public projects. Bidders must comply with the Illinois Statutory requirements regarding labor, including Equal Employment Opportunity Laws.

The College recognizes the importance of increasing the participation of businesses owned by minorities, females and persons with disabilities in public contracts.
