The project consists of renovation of BHC East Campus Building 5 and replacement of Building 6 with a new 19,800 sf Equine Facility including but not limited to: building demolition, concrete slab on grade and foundations, cmu masonry, steel joist and deck, pre-engineered metal building and associated site work. Interior construction includes cmu masonry partitions, equine stalls, fencing & specialties, acoustical tile ceilings, flooring, paint, and hollow metal doors and frames. The construction also includes upgrades to building plumbing, mechanical, lighting, power, and technology systems.
