REQUEST FOR PROPOSAL - REVISED

Contractors are invited to submit an offer for East Campus Well Replacement – Well Completion. Offers will be received at the Finance Office, Room 244A in Building 1, Quad Cities Campus, 6600 34th Avenue, Moline, IL 61265 before 10:00 A.m. local prevailing time on **January 11, 2018**. Bids will be publicly opened and read aloud at that time in the Black Hawk Room, Room 255 in Building 1, Quad Cities Campus.

The project consists of: Completion of Well No. 3, including submersible pump, column, and pitless adapter configuration. Contractor shall provide pre-fabricated two-room well house structure, containing chlorination system for existing Well No. 2 as well as Well No. 3. Discharge piping shall be provided with appropriate valve arrangement, flow meter, and flush hydrant for each well line. Sampling points are to be provided for each well line, with associated mop sink. Contractor shall provide concrete foundation and slab for pre-fabricated well house. Well house shall include pre-engineered HVAC, lighting, convenience receptacles, and miscellaneous electrical facilities, for connection upon arrival on site.

The Owner's existing well controls shall be modified to incorporate control for Well No. 3. The Owner's existing fire alarm system shall be modified, as required. The Owner's existing fuel tank shall be relocated and Lot C Drive widened as shown in the contract documents.

Upon completion work for Well No. 2 and Well No. 3, contractor shall remove and disconnect Well No. 1 pump and related equipment, cap piping, and abandon well in place.

A single stipulated sum bid will be received for all Work.
