Here are all of the questions received by 5:00 p.m. on Friday, May 18, 2018:

Q1: My first question was regarding the optional equipment. I wanted a little clarification, or just a confirmation that I understand correctly. Does the college simply want pricing information for the cost of the listed optional equipment, or is it a preference that the vans have all the listed optional equipment?

A1: The College wants pricing on the listed optional equipment so that it can determine if it would like to add the equipment to some or all of the vans, or not at all.

Q2: In addition, the spare key (remote/non remote type) - Am I correct in assuming the college wants spare keys in addition to the included 2 sets of keys?

A2: Depending on cost, the College will usually order some spare keys in addition to the two (2) sets of keys that are normally provided.

Q3: We are getting the numbers arranged for the bids for Black Hawk College for the 3 Dodge Grand Caravans. Are the vans under Black Hawk College or another way that they are titled? We are searching to see if there is a FAN (fleet account number) to use for pricing for Chrysler. There is nothing under Black Hawk College.

A3: If such Chrysler FAN number were to exist (not sure if it really exists or not), it would indeed be under the actual name Black Hawk College. It should not be listed, say, under Blackhawk College, or any other variation of the name.

Q4: After reviewing the bid documents, we have found the 2018 Dodge Grand Caravan municipality order cutoff date is May 17, 2018. We will not able to place an order after this date for the 2018 model year. The 2019 model year date for order is undetermined at this time. We are unable to submit an accurate bid due to this and wanted to bring this to your attention. Please advise on how you would like us to proceed.

A4: Given the above order cutoff date for municipalities, please submit your most cost effective proposal for what you are able to offer.
